### PermRock Royalty Trust Declares Monthly Cash Distribution

FORT WORTH, Texas, March 21, 2022 – PermRock Royalty Trust (NYSE:PRT) (the “Trust”) today declared a monthly cash distribution to record holders of its trust units representing beneficial interests in the Trust (“Trust Units”) as of March 31, 2022 and payable on April 14, 2022 in the amount of \$863,622.84 (\$0.070988 per Trust Unit), based principally upon production during the month of January 2022.

The following table displays underlying oil and natural gas sales volumes and average received wellhead prices attributable to the current and prior month net profits interest calculations:

Oil cash receipts for the properties underlying the Trust totaled \$2.30 million for the current month, an increase of \$0.11 million from the prior month’s distribution period. This increase was due to an increase in oil prices which more than offset a decrease in sales volumes.

Natural gas cash receipts for the properties underlying the Trust totaled \$0.20 million for the current month, a decrease of \$0.05 million from the prior month’s distribution period. This decrease was due to a decrease in natural gas sales volumes and prices.

Total direct operating expenses, including marketing, lease operating expenses and workover expenses, were \$0.76 million reflecting a \$0.05 million increase from the prior month. Severance and ad valorem taxes were \$0.18 million.

Capital expenditures were \$0.59 million, an increase of \$0.21 million from the prior month. Boaz Energy informed the Trust that this month’s net profits calculation included the application of \$352,000 net to the Trust of funds previously reserved by Boaz Energy.

PermRock Royalty Trust is a Delaware statutory trust formed by Boaz Energy II, LLC (“Boaz Energy”) to own a net profits interest representing the right to receive 80% of the net profits from the sale of oil and natural gas production from certain properties owned by Boaz Energy in the
