PermRock Royalty Trust Declares Monthly Cash Distribution

FORT WORTH, Texas, September 20, 2022 – PermRock Royalty Trust (NYSE:PRT) (the "Trust") today declared a monthly cash distribution to record holders of its trust units representing beneficial interests in the Trust ("Trust Units") as of September 30, 2022 and payable on October 17, 2022 in the amount of \$1,132,255.37 (\$0.093069 per Trust Unit), based principally upon production during the month of July 2022.

The following table displays underlying oil and natural gas sales volumes and average received wellhead prices attributable to the current and prior month net profits interest calculations:

Oil cash receipts for the properties underlying the Trust totaled \$2.89 million for the current month, a decrease of \$0.32 million from the prior month's distribution period. This decrease was due to a decrease in oil prices.

Natural gas cash receipts for the properties underlying the Trust totaled \$0.30 million for the current month, a decrease of \$0.03 million from the prior month's distribution period. This decrease was due to a decrease in sales volumes and natural gas prices.

Total direct operating expenses, including marketing, lease operating expenses and workover expenses, were \$0.81 million reflecting a \$0.11 million increase from the prior month. Severance and ad valorem taxes were \$0.21 million.

Capital expenses this month were \$0.29 million, an increase of \$0.38 million from the prior month's distribution. Boaz Energy reports capital expenses this month were primarily related to returning a Terry County well to production.

Boaz Energy informed the Trust that this month's net profits calculation included \$180,000 net to the Trust of funds reserved by Boaz Energy to cover future capital obligations and expenses.

PermRock Royalty Trust is a Delaware statutory trust formed by Boaz Energy II, LLC ("Boaz Energy") to own a net profits interest representing the right to receive 80% of the net profits from the sale of oil and natural gas production from certain properties owned by Boaz Energy in the Permian Basin of West Texas.
